

CITY OF PALM SPRINGS NOTICE OF APPLICATION PERIOD AND INSTRUCTIONS FOR FY 2017-18 EVENT SPONSORSHIPS AND AGENCY PROGRAM FUNDING

The City Council of the City of Palm Springs will consider requests for the allocation of funding for a limited number of Event Sponsorships and Outside Agency Programs for Fiscal Year 2017-18 to organizations that provide services or events benefitting the Palm Springs Community. Decisions on funding will be made during the City's annual budgeting process and will be based upon the availability of funds; need, as demonstrated through the organization's application; stated objectives of the program or event; past performance by the organization; and the ability to measure progress toward the program objectives. Every Organization and Agency must file a completed application to be considered for funding. In the current fiscal year 2016-17, the City funded \$767,500 in this category (see attached list).

Notice is hereby given the City of Palm Springs is accepting applications for Event Sponsorships and Outside Agency Funding for Fiscal Year 2017-18.

Completed Applications and supplemental materials must be received AT THE OFFICE OF THE CITY CLERK in City Hall, 3200 E. Tahquitz Canyon Way, Palm Springs, CA, 92262 by **3:00 PM**, LOCAL TIME, **MONDAY**, **JUNE 5**, **2017**. The receiving time AT THE OFFICE OF THE CITY CLERK in City Hall will be the governing time for acceptance of Applications. It is the responsibility of the Applicant to see that any material sent through the mail, or by any other delivery method, shall have sufficient time to be received by this specified date and time.

Telegraphic, telephonic, and electronic mail will not be accepted. Postmarks will not be accepted in lieu of actual delivery. Late applications and proposals will not be considered.

The Applicant shall submit ONE (1) Original copy and ONE (1) flash drive of the application and supplemental attachments. In addition, all Fiscal Year 2016-17 recipients must include a one page grant report explaining how those funds were used.

The tentative City Council date for approving the budget for funding for Event Sponsorships and Agency Programing funding for Fiscal Year 2017-18 is Wednesday, July 19, 2017.

For your information, the application and all supplemental materials you submit will be public documents and will be posted on the City's website after the filing deadline.
