<u>SUMMARY</u>

In 2009 the City of Palm Springs had 22 certified neighborhood organizations that were required to submit a report from their annual meetings and their membership lists. Twenty-one of the 22 organizations submitted the information as required and it is on file in the Office of Neighborhood Involvement.

RECOMMENDATION:

Receive and file the following report.

STAFF ANALYSIS:

Of the 22 neighborhood organizations required by Ordinance No. 1666 to submit a report of their annual meetings and their membership lists, 21 submitted a report. The one that did not is Chino Canyon, which currently is not an active organization. However, residents in that area will be contacted to see if there is interest in reactivating the organization.

Membership in the 21 neighborhood organizations was 2,563 people, which is a decrease of 90 from what was submitted the previous year. Part of the reason for the decline may be attributed to a change in how some organizations count members.

By the end of 2009, the City's Office of Neighborhood Involvement was working with 24 neighborhood organizations with membership of 2,918. The neighborhood organizations are listed with their membership counts:
