### SUMMARY

The City Council will consider a resolution confirming and approving the recent protest proceedings for the Palm Springs Business Improvement District, taking no action on the levy of assessments and providing for voluntary assessments for Fiscal Year 2010-11.

### RECOMMENDATION:

Adopt Resolution No. \_\_\_\_\_, "A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PALM SPRINGS, CALIFORNIA, RECITING THE FACT OF THE PROTEST PROCEEDINGS FOR THE LEVY AND ASSESSMENT OF THE FISCAL YEAR 2010-11 PALM SPRINGS BUSINESS IMPROVEMENT DISTRICT, TAKING NO ACTION ON THE PROPOSED LEVY FOR FISCAL YEAR 2010-11, AND OTHER ADMINISTRATIVE MATTERS AS REQUIRED."

### STAFF ANALYSIS:

On June 16, 2010, the City Council conducted a public hearing and evaluated the results of the protest proceedings for the Palm Springs Business Improvement District, as to its intention to modify the basis and method of levying assessments and to renew the fees for Fiscal year 2010-11.

The City Council took no action to adopt Ordinance No. 1744 and the levy of Fiscal Year 2010-11 assessments, and directed the City Clerk to prepare a resolution reciting the fact of the protest proceedings and providing for voluntary contributions.

ITEM NO. 2.0.

The proposed resolution provides for voluntary payments to the BID for Fiscal Year 2010-11, and the authorization to expend rollover funds and voluntary contributions consistent with Ordinance No. 1709 and the Business Improvement District Report, for the purpose of marketing and promotional activities within the District.


Additionally, the City Council will need to appoint the Palm Springs Business Improvement District Advisory Board pursuant to Ordinance No. 1770. The Board shall make recommendations to the City Council on (1) the expenditure of revenues derived from the levy of assessments pursuant to this Chapter, (2) the classification of businesses, (3) boundaries of the District and/or Precincts, (4) the method and basis of levying the assessment, and (5) shall prepare and/or cause to be prepared the Annual Report pursuant to Section 36533 of the California Streets and Highways Code.


FISCAL IMPACT:

The Palm Springs Business Improvement District is a special purpose benefit assessment district; as such, assessments shall only be used for the purpose of the marketing and promotional activities within the District.

Currently, the prior year rollover funds available are \$8,479.

The City does not charge the BID the cost of City staff and administration of the BID, these costs are paid from the General Fund.

RESOLUTION NO. \_\_\_\_\_

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PALM SPRINGS, CALIFORNIA, RECITING THE FACT OF THE PROTEST PROCEEDINGS FOR THE LEVY AND ASSESSMENT OF THE FISCAL YEAR 2010-11 PALM SPRINGS BUSINESS IMPROVEMENT DISTRICT, TAKING NO ACTION ON THE PROPOSED LEVY FOR FISCAL YEAR 2010-11, AND OTHER ADMINISTRATIVE MATTERS AS REQUIRED.

THE CITY COUNCIL OF THE CITY OF PALM SPRINGS HEREBY FINDS AS FOLLOWS:

A. Previously Main Street and the City Council determined that a Business Improvement District would benefit the area to generate revenue to develop and implement a specific marketing program and goals. The City Council determined that the establishment of a business improvement district and the concomitant levy of assessments will promote the economic revitalization of the Downtown and Uptown areas of the City, create jobs, attract new businesses, and help prevent the erosion of these areas. In addition, the maintenance of the business improvement district enhances and furthers the promotion of the City's scenic, recreational, cultural, commercial, and other attractions as tourist destinations.

B. On February 21, 2007, the City Council adopted Ordinance No. 1709, establishing the Palm Springs Business District in the Downtown and Uptown areas of Palm Springs and authorizing the levy of assessments pursuant to the Parking and Business Improvement Area Law of 1989.

C. On May 5, 2010, the City Council adopted Resolution No. 22703 declaring its intention to modify the basis and method of levying assessments and to renew the Palm Springs Business Improvement District fees for Fiscal Year 2010-11, setting the public meeting for May 19, 2010, the public hearing for June 2, 2010, and directing the City Clerk to give notice of said hearing in accordance with Cal. Streets and Highways Code Section 36523 and Section 36534(b).

D. Pursuant to Cal. Streets and Highways Code Section 36534(b), the City Clerk published City Council Resolution No. 22703, Resolution of Intent along with a Notice of Public Hearing, in the Desert Sun on May 8, 2010, and May 13, 2010.

E. On May 6, 2010, pursuant to Cal. Streets and Highways Code and City Council Resolution No. 22703, the City Clerk caused a Notice of Public Hearing, City Council Resolution No. 22703, and a YES/NO ballot, to be mailed to each business paying the assessment within the boundaries of the Business Improvement District, as contained in the official records of the City's Business License System as of May 5, 2010.

F. In addition to the noticing requirements contained in Cal. Streets and Highways Code, the City Clerk caused a Notice of Public Hearing and City Council Resolution No. 22703, to be posted on the legal noticing board and in the City Clerks Office at City Hall on May 6, 2010.

G. On May 19, 2010, the City Council conducted a duly noticed public meeting and introduced for first reading Ordinance No. 1744, "AN ORDINANCE OF THE CITY OF PALM SPRINGS, CALIFORNIA, AMENDING ORDINANCE NO. 1709 RELATING TO THE ESTABLISHMENT OF THE PALM SPRINGS BUSINESS IMPROVEMENT DISTRICT IN THE DOWNTOWN AND UPTOWN AREAS OF PALM SPRINGS AND AUTHORIZING THE LEVY OF ASSESSMENTS PURSUANT TO THE PARKING AND BUSINESS IMPROVEMENT AREA LAW OF 1989, AND CODIFYING ORDINANCE NO. 1709, AS AMENDED, AS DIVISION III OF TITLE 3 (CHAPTER 3.100) OF THE PALM SPRINGS MUNICIPAL CODE."

H. On June 2, 2010, the City Council continued the Public Hearing and the acceptance of protests, to June 16, 2010, and directed the City Clerk to post a Notice of Continuance.

I. On June 3, 2010, the City Clerk caused a Notice of Continued Public Hearing to be posted on the exterior door of Council Chamber, and in the City Clerks Office at City Hall, in accordance with State law.

J. Pursuant to City Council direction, and in accordance with City Council Resolution No. 22703, and the provisions of Cal. Streets and Highways Code Section 36500 *et. seq.*, the City Clerk reviewed, validated, and tabulated the protests to the Fiscal Year 2010-11 assessment and levy, and has submitted the results of such review to the City Council [attached as Exhibit A] and incorporated herein.

K. On June 16, 2010, the City Council conducted a duly notice public hearing, and evaluated the results of the protest proceedings; took no action to adopt Ordinance No. 1744 and the levy of Fiscal Year 2010-11 assessments; and directed the City Clerk to prepare a Resolution reciting the fact of the protest proceedings and other administrative matters.

THE CITY COUNCIL OF THE CITY OF PALM SPRINGS DOES HEREBY RESOLVE AND DETERMINE AS FOLLOWS:

SECTION 1. The City Council confirms and approves the protest proceedings as reported by the City Clerk, and determines that a majority protest was not submitted to the Fiscal Year 2010-11 levy and assessment, but takes no further action for the Fiscal Year 2010-11 levy and assessment.

SECTION 2. Notwithstanding the non-levy of fiscal year 2010-11 assessments in Section 1 of this Resolution, voluntary contributions to the Palm Springs Business

Improvement District may be paid and accepted for fiscal year 2010-11 pursuant to Section 3 of Ordinance No. 1709. The City Manager and/or his designee is authorized to implement policies and procedures for the collection of voluntary contributions.

SECTION 3. The City Manager is authorized to process any expenditures of the Business Improvement District previously collected, as such expenditures are consistent with the activities of the Business Improvement District as outlined in Ordinance No. 1709 and the Business Improvement District Report.

SECTION 4. The City Manager is authorized to expend Palm Springs Business Improvement District prior year Rollover Funds and voluntary contributions in Fiscal Year 2010-11, inasmuch, as such expenditure is consistent with the activities of the Business Improvement District as outlined in Ordinance No. 1709 and the Business Improvement District Report.


