Subject:

Architectural Advisory Committee: Establishment of Process and

Schedule for Reviewing Candidates and Making Appointments

We will meet at 1:30 and following approval of the agenda and receipt of Public Comments, the Commission will conduct the remaining two interviews (candidate applications have already been distributed to the Commission):

1:30 - Gary Fredricks

1:45 - Jim Harlan

Attached are your ballots for the AAC membership selection. Following completion of the interviews, the Commission will select members based on the highest vote getters, as follows:

- 1. The Commission will first vote for three, 3-year positions. The top three vote-getters will be appointed to those positions, ending December 31, 2013. If there is a tie such that more than three candidates are top vote-getters, subsequent voting rounds will be held.
- 2. The Commission will then vote for two 2-year positions from the remaining candidates. Again, subsequent rounds may be held to break ties.
- 3. The Commission will then vote for two 1-year positions from the remaining candidates, including tie-breaker rounds.
- 4. The Alternates will then be selected from the remaining candidates. The candidate receiving the most votes will be granted the two-year position, and the second highest receiving the one-year position.

Since the Code requires that the AAC has at least three licensed architects and one licensed landscape architect, staff has noted which candidates are so qualified. Please note that Mr. Wexler has indicated that he only wishes to be considered for service as an Alternate, so his name is shown on that ballot alone.

Remember that these ballots and the entire interview and voting process are open to the public. Staff will have additional blank ballots available in the event that tie-breaker votes are needed.
