AGREEMENT WITH MSW CONSULTANTS FOR SOLID WASTE

CONTRACT MANAGEMENT

<u>SUMMARY</u>

On June 29, 2009, the City entered into Agreement No. 5859 with MSW Consultants to provide contract administration, oversight, and technical assistance related to the City's Franchise Agreement with Palm Springs Disposal Services. The agreement and three subsequent amendments expired on December 31, 2010. Amendment No. 4 extends the term of the agreement to December 31, 2011, and increases the total maximum compensation by \$13,950 to \$66,270.

RECOMMENDATION:

- Approve Amendment No. 4 to Agreement No. 5859 with MSW Consultants for 1) solid waste contract management services, in an additional amount not to exceed \$13,950 for 12 additional months, ending December 31, 2011, total agreement amount shall not exceed \$66,270; and
- 2) Authorize the City Manager to execute all necessary documents.

STAFF ANALYSIS:

The City entered into a Franchise Agreement (Agreement No. 4727) with Palm Springs Disposal Services (PSDS) effective July 1, 2003. The current agreement expires on June 30, 2016. This amendment provides for an audit for AB 939 fees.

FISCAL IMPACT:

Section 5.04 (b) (5) "Financial Review" of the franchise agreement with PSDS requires that PSDS pay for the Financial Review required under the agreement. Therefore, the City has recovered a portion of the cost of the services provided by MSW Consultants specifically related to the financial review of its business operations, in the amount of \$36,940.00. Sufficient funds are available in the Sustainability Account No. 138-1270-43200.

The following articles of Agreement No. 5859 are hereby amended as follows:

SECTION 1.4 "Term" - is hereby modified to read: Unless earlier terminated in accordance with Section 9.5 of this Agreement, this Agreement shall continue in full force and effect for a period commencing on June 29, 2009 and ending on December 31, 2011, unless extended by mutual written agreement of the parties.

Exhibit "A" "Scope of Services" - (2nd Paragraph) is hereby modified to read: The term of this agreement will be 130 weeks commencing on June 29, 2009 through December 31, 2011.

- 1. Prepare for audit. Obtain info from City; notify PSDS of needed information.
- 2. Perform on-site review of tonnage records.
- 3. Review and analyze tonnage data; compile work papers; review findings with PSDS.
- 4. Prepare draft audit report.
- 5. Review draft audit report with City and PSDS and update as needed.
- 6. Meet with City staff to review audit findings.
