In addition to the above-mentioned expired terms, there is also a vacant position of an Alternate member; Mr. Don Wexler who had to resign last year when he relocated to the City of Palm Desert. This matter was brought to the attention of the Commission a few months ago; at that time, the Commission decided to wait till such a time when the vacancy on the Planning Commission is filled.

Chair Kleindienst and Vice Chair Harlan are not termed out, so these members could be reappointed should the Commission elect to go that route or the Commission could seek for new applicants by directing staff to advertise the vacancies on the committee since three more terms are expiring by December 2012.
