### SUMMARY

The City Council will consider the reappointment of the City of Desert Hot Springs representative to the Palm Springs International Airport Commission.

### RECOMMENDATION:

### STAFF ANALYSIS:

The City has received notification from the City of Desert Hot Springs of their nomination of Jan Pye, as the representative to the Commission.


### ALTERNATIVES:


