SUBJECT: APPROVE OUTFITTING OF POLICE VEHICLES

### SUMMARY

Each Police vehicle must be appropriately outfitted with the necessary equipment to make it operable to perform the job functions of the vehicle operator. Since the vehicles do not come from the manufacturers with the unique specialized equipment required for Police activities, the City must send them to a professional vehicle outfitting shop to be converted. This action would award the outfitting of Police vehicles on a unit price basis as needed through June 30, 2015.

### RECOMMENDATION:

1) Award the outfitting of Police vehicles via a purchase order on a Unit Price Basis of \$12,047.13 for Patrol Sedan Vehicles; \$14,530.83 for Patrol SUV's; \$6,962.45 for Police Admin/Undercover Sedan Vehicles; and \$15,812.50 for K-9 SUV's (*a total purchase price of \$159,537.59 for the current 14 vehicles on-hand*), valid through June 30, 2015, on an as-needed basis, to West Coast Lights & Sirens, Inc., of Riverside, California, inclusive of all applicable taxes and delivery.

2) Authorize the City Manager to execute all necessary documents.

### STAFF ANALYSIS:

Council previously authorized on July 3, 2013 \$626,000 for the acquisition of 15 new replacement vehicles for the Police Department of which we have taken delivery of 14 that are now ready for outfitting. This action will allow the Fleet Operations Division to outfit 6 new Patrol and 4 new Administration/Undercover sedan vehicles, 3 new Patrol SUV's, and 1 new K-9 SUV. It will also allow the outfitting of any other Police vehicles that are acquired on an as-needed basis through June 30, 2015 at the above fixed unit prices per vehicles for the duration of the term. Currently the only remaining police vehicle that has been authorized but not yet received is a pick-up truck.

The Procurement and Contracting Division worked closely with the Fleet Operations and Police Departments to develop the specifications to conduct a formal Invitation for Bid (IFB) 14-09 that was publicly advertised, posted to the City's website, and notices electronically distributed to eight vendors. A Pre-Bid conference was held on January 22nd. Two vendors responded to our invitation for bid and the results are tabulated below:


West Coast Lights & Sirens, located in Riverside, CA, was the lowest, responsive responsible bidder. West Coast has performed Police vehicle outfitting for the City of Palm Springs previously providing quality workmanship and service, and has provided similar services for cities such as Riverside, Redlands, Fontana, and Ontario. Staff is recommending that the City Council award the bid for outfitting of the police vehicles to West Coast Lights & Sirens at the fixed unit prices as shown above that are valid through June 30, 2015 and shall be used on an as-needed basis to outfit additional vehicles as necessary.

**FISCAL IMPACT:**

Funds for the outfitting of vehicles were appropriated and are available in the current 13/14 fiscal year budget account number 510-5475-50020. Of the \$626,000 authorized, approval of this item will bring the total expended to \$560,274.91.

### SUMMARY

This action would authorize staff to purchase 15 new replacement vehicles (6 of which are hybrids or alternative fuel vehicles), for use by the Palm Springs Police Department in a total amount not to exceed \$626,000.

### RECOMMENDATION:

- 1) Approve the purchase of 15 new replacement vehicles for the Palm Springs Police Department in an amount not to exceed \$626,000.
- 2) Adopt Resolution No. \_\_\_\_\_ "A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PALM SPRINGS, CALIFORNIA, AMENDING THE BUDGET FOR FISCAL YEAR 2013-14 FOR POLICE DEPARTMENT REPLACEMENT VEHICLES."

### STAFF ANALYSIS:

The City inventory of vehicles and equipment is examined annually in conjunction with the budget process to determine which units meet criteria established by the City Council in Resolution No. 18834 for replacement.

In keeping with the City of Palm Springs' established commitment to improving air quality in the Coachella Valley, all fleet replacements are evaluated for their operational suitability to the use of alternative fuels.

The gasoline/electric hybrids proposed provide an average of 50% increased mileage, have proven to be reliable as they are all factory vehicles and are the recommended choice to meet the City's alternative fuel vehicle goals.

The Police Department vehicles recommended to be replaced along with specific vehicle information is attached, at an estimated cost not to exceed \$626,000.

In September, City Staff will bring forward recommendations for replacement vehicles for all other City Departments.

FISCAL IMPACT:

Police Department vehicle replacement is not to exceed \$626,000.


Funds for this purchase will be appropriated from the Motor Vehicle Replacement (MVR) fund balance using the attached Budget Amendment Resolution.

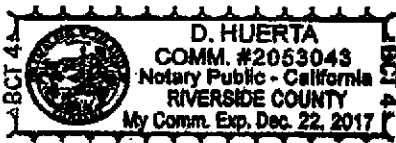

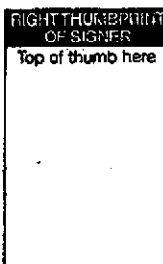

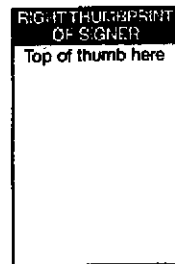
