SUMMARY

The City Council will consider the reappointment of the City of Indio representative to the Palm Springs International Airport Commission.

RECOMMENDATION:

STAFF ANALYSIS:

In November, 2007, the City Council amended the Palm Springs Municipal Code to provide that each representative City nominate, and the Palm Springs City Council appoint the representative member to the Palm Springs International Airport Commission.
