Investigation for possible Class 1 Designation

At the March 2014 HSPB meeting, the board directed staff to contact the owner of the Palm Springs Racquet Club (Olivia Communities, Inc.) to arrange a possible site visit in conjunction with the board's initiation and investigation of the site for possible recommendation to the City Council for Class 1 historic designation. (This investigation was initiated by the board in May of 2012).

Attached is correspondence from the owner indicating that at this time, they would prefer not to pursue historic designation for the Palm Springs Racquet Club and thus have respectfully declined the City's request for a site visit. Although owner support and participation is not a requirement of the City's Historic Preservation ordinance for Class 1 designation, staff believes a cooperative effort and support of any historic designation recommendation always makes for a stronger recommendation to the City Council.

I have forwarded to the owner, Mills Act information and the materials prepared by staff since December 2013 on the evaluation of the site for eligibility for possible Class 1 historic designation.

At this time, staff recommends the HSPB conclude its investigation on possible designation of the Racquet Club and direct staff to retain the information in the HSPB case file on this property. Once the owner has completed the current capital improvements at the site, the board may wish to initiate outreach to the owner again. At that time, the Board may determine whether wishes to re-open the nomination and make a recommendation to the City Council or take no action.

Staff is seeking direction from the Board on how it wishes to proceed.
