SUMMARY

Pursuant to Division 9, Part 3, Chapter 4 of the Streets & Highways Code (Section 8330 et. seq.) outlines the process to follow to summarily vacate streets and public service easements. In accordance with Section 8330(a) of the statute, the legislative body of a local agency may summarily vacate a street or highway that has been superseded by relocation.

RECOMMENDATION:

Adopt Resolution No. _______"A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PALM SPRINGS, CALIFORNIA, VACATING AND ABANDONING ALL OF ITS RIGHT, TITLE, AND INTEREST IN PORTONS OF RIGHTS-OF-WAY FOR MICRO PLACE AND SALVIA ROAD, AT THE GENE AUTRY TRAIL & I-10 INTERCHANGE, IN SECTION 30, TOWNSHIP 3 SOUTH, RANGE 5 EAST, S.B.M.; FILE NO. R 14-13 (RCTD No. A4-0740)."

STAFF ANALYSIS:

On April 2, 2014 the City of Palm Springs Engineering Department was contacted by the Supervising Land Surveyor, of the Riverside County Transportation Department requesting the City to vacate and abandon portions of the rights-of-way for the old alignments of Micro Place and Salvia Road, west and east, respectively, of Gene Autry Trail, south of the Interstate 10 freeway. This request is in conjunction with the

interchange improvements for Gene Autry Trail and Interstate 10 that were completed in 2010. With the interchange improvements, the rights-of-way for Micro Place and Salvia Road were adjusted, and the roads relocated and realigned to coincide with the newly widened Gene Autry Trail alignment. All utilities and drainage facilities were relocated and to correspond with the newly reconstructed roads. The only remaining process is to vacate those portions of the old rights-of-way for Micro Place and Salvia Road that are in excess and unnecessary.

Micro Place and Salvia Road were originally shown on CalTrans Map Number 405571 thru 405574 (Approved September 30, 1964), on file as Riverside County Map Number 204, pages 490-493. They were acquired by Final Order of Condemnation (FOC), recorded in December of 1969 (Inst. No. 127863), and relinquished to Riverside County on March 5, 1970 (Inst. No. 20923). These roads were subsequently annexed by the City of Palm Springs in December 1991 (Inst. 437743) as part of Annexation 24 & 25 (LAFCO 91-21-3 & 4). The new right-of-way alignments are shown on CalTrans Map Number 413516-7 thru 413516-9 (Approved December 1, 2008), on file as Riverside County Map Number 205, pages 362-364, and were granted to the City of Palm Springs by the County of Riverside on November 30, 2011 (Inst. No. 0526646). There was a question early on in the process that required substantial evaluation regarding the status of these rights-of-way, and whether they were in fee or easement. The County Surveyor, CalTrans, and a Commercial Title Officer reached the conclusion that the roads were, in fact, by easement.

Pursuant to aforementioned California Streets & Highways Code, Sections 8330(a), the Staff recommends the City Council approve the Summary Vacation for portions of old rights-of-way for Micro Place, as described in Exhibit "A" and shown on Exhibit "B", and Salvia Road, as described in Exhibit "C", and shown on Exhibit "D", at the Gene Autry Trail and south of Interstate 10 interchange in Section 30, Township 3 South, Range 5 East, S.B.M., and described in Exhibits "A" and shown on Exhibits "B".



R 14-13: VACATION OF PORTIONS OF MICRO PLACE AND SALVIA ROAD

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PALM SPRINGS, CALIFORNIA, VACATING AND ABANDONING ALL OF ITS RIGHT, TITLE, AND INTEREST IN PORTONS OF RIGHTS-OF-WAY FOR MICRO PLACE AND SALVIA ROAD, AT THE GENE AUTRY & I-10 INTERCHANGE, SECTION 30, TOWNSHIP 3 SOUTH, RANGE 5 EAST, S.B.M.; FILE NO. R 14-13 (RCTD No. A4-0740).

WHEREAS, the City Council of the City of Palm Springs, California, is authorized by Division 9, Part 3, Chapter 4 of the Streets and Highways Code of the State of California (the "statute"), to vacate and close to the public use, excess right-of-way of a street or highway, within the limits of the City; and

WHEREAS, pursuant to Section 8330(a) of the statute, the legislative body of a local agency may summarily vacate a street or highway that has been superseded by relocation; and

WHEREAS, the new public right-of-way alignments for Micro Place and Salvia Roads are shown on CalTrans Map Number 413516-7 thru 413516-9 (Approved December 1, 2008), on file as Riverside County Map Number 205, pages 362-364, and were granted to the City of Palm Springs by the County of Riverside on November 30, 2011 (Inst. No. 0526646).; and

WHEREAS, the new public right-of-way alignments for Micro Place and Salvia Roads were granted to the City of Palm Springs by the County of Riverside in Instrument No. 0526646 on November 30, 2011; and

WHEREAS, the new public rights-of-way for Micro Place and Salvia Roads have been realigned due to the improvements to the Gene Autry Trail and Interstate 10 interchange per said CalTrans Map Number 413516, all encompassed utilities and drainage facilities have been relocated, and the roads have been reconstructed. The only process remaining is to vacate and abandon any excess existing public right-of-way within the old rights-of-way for Micro Place and Salvia Roads; and

WHEREAS, the portions of old rights-of-way for Micro Place, as described in Exhibit "A" and shown on Exhibit "B", and Salvia Road, as described in Exhibit "C", and shown on Exhibit "D".


