BACKGROUND AND ANALYSIS:

Each year the City Council selects ad hoc two-member City Council Subcommittees to interview and screen candidates for the City's Commissions and Boards, with the exception of the Measure "J" Oversight Commission, Historic Site Preservation Board and the Planning Commission, which the City Council has interviewed candidates as a whole at an open and public meeting.

The ad hoc City Council Subcommittees interview and screen applicants, and make recommendations to the entire City Council; and members of Commission and Boards are appointed by three affirmative votes of the City Council.
