PURCHASE A NETWORK SERVER AND ASSOCIATED SOFTWARE

SUMMARY

On July 15, 2015, City Council accepted a Department of Justice, Justice Assistance Grant (JAG) award in the amount of \$20,031 and signed an Interlocal Agreement with the cities of Banning, Cathedral City, Coachella, Corona, Desert Hot Springs, Hemet, Indio, Jurupa, La Quinta, Moreno Valley, Perris, Riverside, and the County of Riverside, authorizing the County of Riverside to administer the grant on behalf of participating agencies. Under the agreement, the City of Palm Springs would release \$2,003, administration fee, to the County of Riverside, leaving an award balance of \$18,028. All of the remaining funding from the JAG grant would be used to purchase a needed network server and associated software and any additional funds necessary to cover the remaining balance would come from other funding sources.

RECOMMENDATION:

- Approve the purchase of a new PowerEdge R730 Server and associated software from Dell Inc. utilizing the national cooperative NASPO ValuePoint agreement #WN03AGW in the amount of \$26,102.96
- Authorize the City Manager to execute all necessary documents.

STAFF ANALYSIS:

The United States Department of Justice awards annual grants entitled Justice Assistance Grant (JAG) to law enforcement agencies. JAG funds may be used for a variety of public safety programs and equipment.

The Police Department planned to use these grant funds to purchase a new network server. Currently, there are servers dedicated for our CAD (dispatch) and Records Management System (RMS). One server requires immediate replacement and the other two are near capacity.

Pursuant to the provisions of the Procurement Ordinance, 7.09.010, the City Council

may authorize the acquisition of equipment through a joint powers or other cooperative purchasing program. The City's Procurement Department participates in the National Association of State Procurement Officials (NASPO) ValuePoint program to further leverage the purchasing power of the City via the economies of scale afforded by pricing achieved from larger agencies via a competitive process that would likely be less than what we could obtain independently. Dell Inc. offers the needed server and associated software through the NASPO ValuePoint contract WN03AGW.

FISCAL IMPACT:

There is no fiscal impact to the City budget. JAG funds from account 261-3201-52105 will be used and the remaining funds will come from the SLESF fund account 261-3201-52101
