### SUMMARY

The City Council will consider the appointment of the City of Cathedral City representative to the Palm Springs International Airport Commission.

### RECOMMENDATION:

Appoint Mitchell Spike as the City of Cathedral City representative, to the Palm Springs International Airport Commission for the term ending June 30, 2018.

### STAFF ANALYSIS:

In November, 2007, the City Council amended the Palm Springs Municipal Code to provide that each representative City nominate, and the Palm Springs City Council appoint the representative member to the Palm Springs International Airport Commission.

The City has received notification from the City of Cathedral City of their nomination of Mitchell Spike as the City of Cathedral City representative to the Commission, for the term ending June 30, 2018.
