Below are the City Council ad hoc subcommittee recommendations for appointments to the Boards and Commissions.

Human Rights Commission
(Mayor Pro Tem Foat and Councilmember Kors)
Three openings available for appointment

Appoint David Morgan, Jim Gross and Nicki Randolph to the Human Rights Commission for terms beginning July 1, 2017 to Jun 30, 2020.

Parks & Recreation Commission
(Mayor Pro Tem Foat and Councilmember Mills)
Three openings available for appointment

Re-appoint Miguel Navarro, and appoint Jody Diaz and Trent Pace to the Parks & Recreation Commission for terms beginning July 1, 2017 to June 30, 2020.

Board of Library Trustees
(Mayor Moon and Councilmember Mills)
One opening available for appointment

Re-appoint Harry R. Courtright to the Board of Library Trustees for term beginning July 1, 2017 to June 30, 2020.

Sustainability Commission
(Councilmember Kors and Councilmember Roberts)
Four openings available for appointment

Re-appoint David Freedman and Greg Gauthier to the Sustainability Commission for terms beginning July 1, 2017 to June 30, 2020.

Two openings available for appointment



Following are the Boards and Commissions that will conduct interviews after this Staff Report is prepared and distributed. Nominees will be presented at future City Council meetings for consideration:

1. VillageFest Board; Interviews scheduled for June 20, 2017—Three openings; One term ending June 30, 2019 and two terms ending June 30, 2020.
2. Administrative Appeals Board; Interviews scheduled for June 21, 2017—Two openings; One term ending June 30, 2018 and one term ending June 30, 2020.
3. Board of Appeals; Interviews scheduled for June 21, 2017—Three openings with no term limits.
4. Public Arts Commission; Interviews scheduled for July 5, 2017—Two openings with terms ending June 30, 2020.
5. The Planning Commission/Historic Site Preservation Board and Measure J Oversight Commission interviews will be scheduled for July 6, 2017, with the full City Council.
