SUBJECT: PALM SPRINGS BUSINESS IMPROVEMENT DISTRICT, RECITING AND APPROVING THE PROTEST PROCEEDINGS, CONSIDER THE FISCAL YEAR 2009-10 LEVY OF ASSESSMENT FEES.

SUMMARY

The City Council will review and approve the protest proceedings for the Fiscal Year 2009-10 levy of assessments for the Palm Springs Business Improvement District, and consider the levy of assessment fees.

RECOMMENDATION:

1. The Public Hearing was closed on June 24, 2009, take no additional public testimony.
2. Adopt a Resolution with regard to the Palm Springs Business Improvement District.
3. Direct staff as appropriate.

STAFF ANALYSIS:

The City Council conducted a duly noticed public hearing for the Palm Springs Business Improvement District, pursuant to City Council Resolution No. 22494 and Cal. Streets and Highways Code, known as the Parking and Business Improvement Law of 1989. The full administrative record is contained in the findings of the resolutions attached to this report.

At and during the public hearing, the City Council received testimony and verbal and written protests to the Palm Springs Business Improvement District Fiscal Year 2009-10 levy of assessments. At the public hearing a substantial number protests were filed, and staff was unable to verify and tabulate the results at the close of the public hearing. The City Council closed the public hearing, along with the acceptance of protests, and directed the City Clerk to review the protest proceedings.

ITEM NO. 1.B.

Pursuant to City Council Resolution No. 22494 and State law, protests are weighted proportionately and based on the amount of the proposed assessment. Thus the number of protests submitted is not factor in determining a majority protest. For instance, a protest received from a qualified business in the district that pays an assessment of \$150 has a relative value that is less than a protest received from a qualified business in the district that pays an assessment of \$500.

The City received a total of 175 valid protests with a total assessment value of \$55,550. The total proposed and estimated assessments for the entire district is \$130,660. Thus the protest percentage 42.5%. All protests received are on file in the Office of the City Clerk for review and inspection by the City Council, interested persons, and the general public.

Pursuant to City Council Resolution No. 22494 and State law, the City Council may waive any irregularity in the form or content of any protest, and/or correct minor defects in the proceedings. The City Council may amend or otherwise modify the results of the protest proceedings as it deems appropriate.

Since 50% protest was not received of the total proposed assessments, the City Council may proceed with the levy of the assessments by adopting the proposed resolution (Alternative Motion No. 1).

However, the receipt of less than 50% protest does not preclude the City Council from choosing to not enact the levy the assessments. Staff has prepared a resolution for the City Council to take no further action to levy the assessment for Fiscal Year 2009-10 (Alternative Motion No. 2).




FISCAL IMPACT:

The levy of 2009-10 Business Improvement District assessment fees would generate approximately \$130,000 in revenue for the specific use of marketing and promotional activities in the Downtown and Uptown area. The 2009-10 Business Improvement District Report provides for the expenditure of \$125,905 in Fiscal Year 2009-10. Any fees collected in excess of expenditures, would roll over to the future year(s). As of July 8, 2009, the collective roll over amount for previous years is \$34,609.

The levy does not impact the General Fund, with the exception of City administrative staff costs. Currently, the City does not charge an administrative fee, to cover the General Fund cost of administering the Business Improvement District.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PALM SPRINGS, CALIFORNIA, RECITING THE FACT OF THE PROTEST PROCEEDINGS FOR THE LEVY AND ASSESSMENT OF THE FISCAL YEAR 2009-10 PALM SPRINGS BUSINESS IMPROVEMENT DISTRICT, AND RENEWING THE LEVY OF ASSESSMENT FEES FOR FISCAL YEAR 2009-10.

THE CITY COUNCIL FINDS AS FOLLOWS:

A. Previously Main Street and the City Council determined that a Business Improvement District would benefit the area to generate revenue to develop and implement a specific marketing program and goals. The City Council determined that the establishment of a business improvement district and the concomitant levy of assessments will promote the economic revitalization of the Downtown and Uptown areas of the City, create jobs, attract new businesses, and help prevent the erosion of these areas. In addition, the maintenance of the business improvement district enhances and furthers the promotion of the City's scenic, recreational, cultural, commercial, and other attractions as tourist destinations.

B. On February 21, 2007, the City Council adopted Ordinance No. 1709, establishing the Palm Springs Business District in the Downtown and Uptown areas of Palm Springs and authorizing the levy of assessments pursuant to the Parking and Business Improvement Area law of 1989.

C. On June 3, 2009, the City Council adopted Resolution No. 22494 declaring its intention to renew the Palm Springs Business Improvement District fees for Fiscal Year 2009-10, setting the public hearing for June 17, 2009, and directing the City Clerk to give notice of said hearing in accordance with Cal. Streets and Highways Code Section 36534(b).

D. Pursuant to Cal. Streets and Highways Code Section 36534(b), the City Clerk published City Council Resolution No. 22494, Resolution of Intent, in the Desert Sun on June 6, 2009.

E. Furthermore, in addition to the noticing requirements contained in Cal. Streets and Highways Code Section 36534(b), the City Clerk published a Notice of Public Hearing, in the Desert Sun on June 6, 2009.

F. Furthermore, in addition to the noticing requirements contained in Cal. Streets and Highways Code Section 36534(b), the City Clerk caused a Notice of Public Hearing and City Council Resolution No. 22492, to be mailed to each business paying the assessment within the boundaries of the Business Improvement District, as report by the City's Finance Department, Business License System.

G. Furthermore, in addition to the noticing requirements contained in Cal. Streets and Highways Code Section 36534(b), the City Clerk caused a Notice of Public Hearing and City Council Resolution No. 22492, to be posted on the legal noticing board and in the City Clerks Office at City Hall on June 4, 2009.

H. On June 17, 2009, the City Council conducted a duly notice Public Hearing, and the acceptance of verbal and written protests to the levy of the assessments. The City Council continued the Public Hearing and the acceptance of protests, to June 24, 2009, and directed the City Clerk to post a Notice of Continuance.

I. On June 18, 2009, the City Clerk caused a Notice of Continued Public Hearing to be posted on the exterior door of Council Chamber, and in the City Clerks Office at City Hall, in accordance with State law.

J. In addition to the noticing requirements contained in Cal. Streets and Highways Code, on June 22, 2009, City Code Enforcement staff walked the boundaries of the Business Improvement District, and hand delivered City Council Resolution No. 22492, Notice of Intention, and a Notice of Public Hearing, to all businesses located within the District.

K. On June 24, 2009, the City Council continued the Public Hearing and the acceptance of protests. The City Council closed the public hearing and the acceptance of further protests, and directed the City Clerk to review and tabulate the protests to the Fiscal Year 2009-10 assessment and levy, and further directed the City Clerk to place such matters on the July 15, 2009, City Council Meeting Agenda.

L. Pursuant to City Council direction, and in accordance with City Council Resolution No. 22492, and the provisions of Cal. Streets and Highways Code Section 36500 et. seq., the City Clerk reviewed, validated, and tabulated the protests to the Fiscal Year 2009-10 assessment and levy, and has submitted the results of such review to the City Council [attached as Exhibit A] and incorporated herein.

THE CITY COUNCIL OF THE CITY OF PALM SPRINGS DOES HEREBY
RESOLVE AND DETERMINE AS FOLLOWS:

SECTION 1. The City Council confirms and approves the protest proceedings as reported by the City Clerk, and determines that a majority protest was not submitted to the Fiscal Year 2009-10 levy and assessment.

SECTION 2. The City Council hereby amends and approves the Palm Springs Business Improvement District Report [attached as Exhibit B] and incorporated herein. The Report is amended to include the provisions of Section 4, Section 5, and Section 6 of this Resolution.

SECTION 3. The City Council hereby renews the Palm Springs Business Improvement District fee pursuant to the Law and levy assessments for the purpose of marketing and promoting activities which will benefit the businesses located and operating within the area of the Business Improvement District for Fiscal Year 2009-10.

SECTION 4. The boundaries of the District shall be the areas described on the map of the District on file in the Office of the City Clerk and shall include:

All businesses on Palm Canyon Drive, north of Ramon Road and south of Tachevah Drive along the east and west sides of the street; Indian Canyon Drive, north of Ramon Road and south of Alejo Road along the east and west sides the street; Belardo Road, north of Ramon Road and south of Alejo Road on the east and west sides of the street; Museum Drive on the east and west sides of the street; Tahquitz Canyon Way west of Indian Canyon Drive on the north and south sides of the street; Andreas Plaza; and Amado Road, Arenas Road, La Plaza Way and Baristo Road from Indian Canyon Drive west to Belardo Road.

SECTION 5. The City Council hereby adopts the schedule of assessments described below, which are unchanged from the 2008-09 fiscal year, to be levied on the businesses within the District for the purpose of funding, providing, or promoting activities which benefit businesses located and operating in the District, to the maximum extent permitted under the Law. The amount of the assessments shall be in accordance with the following table:

New businesses shall not be exempt from the payment of any applicable assessment.

SECTION 6. That the proposed assessments shall be levied on each business required to pay business license taxes and located within the area of the District. The assessments are proposed to be paid, collected, and administered in the manner business license taxes are paid, collected, and administered in accordance with Division II of Title 3 of the Palm Springs Municipal Code.

SECTION 7. The City Council has reviewed the 2008-09 Budget and Program and approves the 2009-10 Budget and Plan of Work.

SECTION 8. The Director of Finance is hereby authorized and directed to collect any outstanding assessments for businesses delinquent in the payment of assessments.

SECTION 9. The City Manager is authorized to process any expenditures of the Business Improvement District previously collected, as such expenditures are consistent with the activities of the Business Improvement District as outlined in Ordinance No. 1709 and the Business Improvement District Report.

The City Manager is authorized to expend Palm Springs Business Improvement District Rollover Funds in Fiscal Year 2009-10, inasmuch, as such expenditure is consistent with the activities of the Business Improvement District as outlined in Ordinance No. 1709 and the Business Improvement District Report.





SUBJECT: ANNUAL REVIEW AND RENEWAL OF THE PALM SPRINGS BUSINESS IMPROVEMENT DISTRICT AND ADOPTION OF THE 2009-10 YEAR PROGRAM

SUMMARY

The approval of the attached Resolution is required for the City to renew the Palm Springs Business Improvement District (BID) for the 2009-10 Fiscal Year. This special benefit assessment district only affects businesses located in the specific geographic area outlined below. The assessment fees range from \$150 to \$500 per year depending the type and square footage of the business. The assessment fees are collected annually through the business license renewal and new application process.

RECOMMENDATION:

1. Adopt Resolution _____, "A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PALM SPRINGS, CALIFORNIA, TO RENEW THE LEVY OF ASSESSMENT FOR THE 2009-10 FISCAL YEAR FOR THE PALM SPRINGS BUSINESS IMPROVEMENT DISTRICT."

STAFF ANALYSIS:

On June 3, 2009 the City Council adopted Resolution No. 22494 declaring its intention to renew the Palm Springs Business Improvement District (BID) for the 2009-10 Fiscal Year. At that meeting the City Council set a Public Hearing date in accordance with the Streets and Highways Code Sections 36530 – 36537. These actions would approve the program budget and report submitted by the Palm Springs Business Improvement District Steering Committee; and approves the levy of assessment for the 2009-10 Fiscal Year.

The Public Hearing is a protest procedure in which affected interested parties may protest the adoption of the Resolution of the Business Improvement District either in writing prior to the Public Hearing date or during the Public Hearing comment period. The Public Hearing Notice was published once in the Desert Sun on June 6, 2009 and

322 notices were mailed to businesses located within the geographic boundaries of the BID and identified by the City's business license database.

The Palm Springs Business Improvement District encompasses all businesses located on Palm Canyon Drive, north of Ramon Road and south of Tachevah Drive along the east and west sides of the street; Indian Canyon Drive, north of Ramon Road and south of Alejo Road along the east and west sides the street; Belardo Road, north of Ramon Road and south of Alejo Road on the east and west side of the street; Museum Drive on the east and west sides of the street; Tahquitz Canyon Way west of Indian Canyon Drive on the north and south sides of the street; and La Plaza, Andreas Plaza; and Amado Road, Arenas Road, Baristo Road from Indian Canyon Drive west to Belardo Road.

The levy of assessment is based on the type of business and the square footage and/or number of seats or rooms. Businesses located within the defined geographic area pay the BID fees based on the following schedule:

Note: Non-profits which do not need business licenses would be exempt from the BID fee; however, they would still be included in downtown promotional materials such as maps or directories.

Revenues are maintained in a separate fund and dedicated to the defined area. Assessment collections and disbursements are handled through the City's Finance Department.

Attached to the staff report is the 2009/2010 Business Improvement District Budget & Plan of Work, approved by the Business Improvement District Steering Committee and Main Street Association on April 21, 2009. The Report also includes the 2008-09 budget and projects.

FISCAL IMPACT:

Finance Director Review:

There is no impact to the General Fund. All revenues generated from this program are dedicated to marketing and promotion activities within the defined geographic boundaries. The budget includes continuing appropriations from the current fiscal year; which brings the income/funding estimates to \$135,000 for the 2009-10 fiscal year (pages 6-8).
