VII. STAFF UPDATES:

Donn Uyeno:

On September 24, 2020, the City Council approved 7 projects from the **Parks & Recreation Commission's Priority Projects**, here are the remaining ones:

- 1. Pavilion Sound System January target for installation. Electronic components are hard to source.
- 2. Playground Surfacing Under construction. Contractor has completed the small playground at Desert Highland Park, and it is open to the public. The large playground needs about 20 more tiles before it is done. The contractor has completed demolition of the existing old playground surface at Demuth Park.
- 3. Ballfield Lighting Design— Consultant continues to work on lighting levels, pole placement, and system layout.

Other Park Projects under construction:

Demuth Park and Desert Highland Park Restrooms – Contractor is waiting for materials to arrive.

Demuth Community Center HVAC – The project will be awarded at the next City Council meeting.

Commissioner Goodman asked about the sand ordered for the dog park, Director Schafer answered.

Commissioner Miraglia asked about information on Baristo Park, both Interim Director Kays and Interim Director Schafer were able to answer questions

Chair Alcorn commented on the events

Interim Director Kays reported on the City Council retreat and updates

Commissioner Crawford asked questions about Baristo Park being closed, Director Schafer was able to answer the questions

Director Staci Schafer:

Director Schafer gave updates on benches being painted, trash can replacements, TOT statue at Swim Center, staff moving Spider art to new location.

Commissioner Meyer asked about how the community can check on updates. Directors Schafer and Kays answered.

Commissioner Diaz referred to a past email correspondence that talked about a park bench being moved and wanted it on record that the Commission did not have it moved. Director Schafer commented that the benches had been moved because of the shade structure installation, and had been returned to the proper area.

Vice-Chair Coladonato asked about placing caution tape up around the fields during reseeding. Director Schafer stated that her goal was to keep adding necessary items to keep the fields healthy rather than keep people out of the parks.

Director Schafer discussed using separate funds for a walking path from Measure J funds, and is working with DWA on having a DG walking path. Commissioner Goodman asked about the walking paths, Director Schafer was able to answer the questions.

3. DISCUSSION OF VOLUNTEERS AND ASSIGNMENTS TO COMPLETE AND SUBMIT MEASURE J APPLICATIONS:

Chair Alcorn suggested one person work on each application, so as to distribute the workload.

Commissioners Goodman and Miraglia will do the application for the dog park.

Commissioner Meyer will do the application for the exercise equipment at the Wellness and JOJ Parks, and an application for the Sunrise Park Committee.

Chair Alcorn will do the fencing project at the Swim Center.

Directive was that Commissioners would submit the applications on their own. Commissioner Meyer asked for clarification of sending the application on behalf of the Commission.

Interim Director Kays and Chair Alcorn will do an application for the lockers at the Swim Center to be replaced.

Donn Uyeno clarified that the actual costs do not necessarily need to be submitted.

Commissioner Goodman asked about the equipment at the Sunrise and Wellness Parks.

Chair Alcorn discussed updating the Master Plan.

Commissioner Goodman shared that she was meeting with the (PSUSD) schools and Measure J representatives to discuss having equipment in the parks located near the schools.

Discussion was held on number of application submissions, possibility of emailing as an official record documenting that the applications were submitted, and the need to discuss the applications at the December Commission Meeting.

They identified 15 items for funding, i.e. repaving, new/more BBQ units, water fountains, repairs, equipment, etc. Chair Alcorn said he had 24 items on his list that needed attention such as safety issues, upgrades needed.

Commissioner Goodman stated that the Dog Park Subcommittee hasn't met, but will be doing application submission for funding.

Interim Director Kays introduced the new Assistant City Manager, Teresa Gallavan. Manager Gallavan gave her background and said she looked forward to working with everyone.

Chair Alcorn welcomed her.

To whom it may concern -

My name is Sean Bulmer. I am the owner of Maverick Tennis in Palm Springs, CA. I am writing you as a formality as it appears my request is dead in the water before it's even been presented.

As you surly must know, over the last 7 years Palm Springs has gone from world class tennis destination to tennis graveyard. Even in a global pandemic that disallows every single sport with the exception of golf and tennis zero programming exists at Ruth Hardy Park. A community sport in which a tennis court in Southern CA is worth aprox. \$80,000.00 a year to its Parks Department sits empty. A sport that the CDC tells us if played 3 hours a week can cut in half the risk of almost any deadly disease, remains unused. Weather my conspiracy or incompetence the Peoples Courts sit rotting, unwashed and unlit. Why is that? Like it or not our Park & Recreation department is a governmental entity. It's socialism at its very finest serving ALL of The People no matter ethnicity, country of origin, religion, age, sexual orientation, or economic background. The "World oldest social network" is also the most socially distanced safe sport requiring 78' between players. It is custom made for the physical and emotional challenges we face today. Yet despise a few lightbulbs being replaced and a return to a few lot courts at Ruth Hardy Park, the city's own app. warns local and visitors alike "No lights available until further notice." Why is that?

I lived in PS proper from 2012-2016. As a 3rd gen California and San Francisco native I've called Palm Springs a second home all of my adult life. My grandfather and my grandmother, a DiMaggio from SF, used to bring me down here as a kid so I could learn how to play tennis and how to be a gentleman. One out of two isn't bad. I returned to PS in October of 2020 with one goal in mind... to return tennis to the city that literally owes its life to Tennis and the movie stars that played it. For God sake's there's a 9 foot bronze statue of Charlie Farrell aka Mr. Palm Springs, a former mayor and well-known actor who opened the Racquet Club a Palm Springs in 1934. In fact I run the Facebook page for the club. But when I returned I found a negative undercurrent at the park. Worse yet, I found tribalism between a sport and a recreation that has divided a Ciry, it's snowbirds and it's guests. There's no possible way any of you do not know what's been going on. Yet you sit by and watch as though nothing has happened. Why is that?

I did not return to play Police-person, therapist, or become the Messiah of Tennis. For 15 months I've worked diligently to sever that negative influence from Ruth Hardy Park and embrace Pickleball as one of their fellow players. In fact I took free Pickleball lessons last summer at 6:15 in the morning before I went to Palm Springs high school to give an hour of tennis tour local children to the park and rec department. Things are dramatically different at Ruth Hardy Park and I've been embraced by most of the pickle ball players. I've said it before and I'll say it again, I am pro recreation. I am pro Arts. I seek harmony, not chaos. I shouldn't have to be telling any of you this nor should I have to be doing your work for

you. I'm willing to take a bullet on behalf of others. One of the final pieces of the puzzle is an event I produced called the I Heart Tennis round robin tournament. The dates are February 12 and 13th Valentine's Day weekend. That weekend was originally scheduled for a Sanctioned senior tournament. Despite having created a bridge between United States tennis Association and the park in Recs Department of Palm Springs California I've yet to see any real support from the governing body of Tennis. Therefore at the request of the regulars Who play at the park I pivoted to a locals tournament instead. I'm asking the city for an in-kind donation that would pay for the printing of the flyers for the tournament as well as the court fees. Court fees I may add, that do not include cleaning of the courts or their lighting. Why is that?


I've already received my answer. To paraphrase, "If we do it for him we will have to do it for everyone." That attitude doesn't make me angry. It doesn't even frustrate me. To be honest, it kind of breaks my heart. People are dying. People are taking their own lives. People are unhoused, people are unemployed. People are loosing faith in their own government. I returned to give our cities unofficial sport a little nudge. But what I found was a park in disarray and our cities official sport abandoned. Someone very special to me asked me to go the extra mile and try to heal some of the past wounds our tennis community still suffers. I won't bother you all with what my answer was, but I can promise you it wasn't, "If I do it for them I'll have to do it for everyone." Why is that?

A portion of the proceeds are earmarked to provide free and affordable programming for youth and senior residence of Palm Springs she's a Palm Springs park and recreation department.



Below is the body of the message sent via your online message system:

This request is for the Demuth Park Pickleball courts. It appears that the sprinklers near the courts are now putting out so much water that the courts are being flooded. Along with that is all the sand and dirt that get picked up by the water and then dry onto the courts making them very dangerous. I have personally fallen down once due to these uneven sand deposits on the court. Someone will definitely get hurt if this safety issue is not taken care of by the city. I have also noticed that the sprinkler settings are causing the parking lot to be watered as well. I have pictures that I will send from my email address

I ask that you put priority on this matter before someone astuslly gets hurt from the courts being so dirty and sometimes wet from the excess sprinkling of the surrounding grass.

Greetings -

I was at both Demuth Park and RHP today, yesterday and Demuth rhis ans last evening. While not all lamps are working the lights were on at 5:10pm today at Demuth but not at 7:30pm last night. I'll deal with Demuth Park through other means moving forward.

I had a very insightful discussion with about a dozen or so regulars at RHP late this morning. I felt obligated to face them in terms of what i noticed today is a lack of signage on the courts with our tournament dates. To my surprise not only was everyone warm and greeting, they were in clear support of the event despite it monopolizing 8 hours in a day. Some had assumed it was this weekend after seeing the story in the Desert Sun.

As I've mentioned I'm about harmony from chaos. Sometimes it take chaos to achieve harmony but you get the idea. Without a solicitation from me the players started pointing out not only the below standards condition of the courts in terms of tournament play, according to them this has been an ongoing issue. I'm a subscriber to the philosophy that there are three such to every story, yours, mine, and the truth. Weather there is any truth to the courts not bring cleaned I cannot say. They were rented to an organization serving a local 5013c at a premium price. We expect standard courts in standard condition. They aren't lit for tournaments so the event is dragged into an additional day. Nobody has yet to mention the surrounding grass is being seeded thus eliminating access to viewers and use of the picnic tables, I would assume. My first application vanished into thin air, and I've had to produce a third and final application. I've offered to be on sight as a guide for detailing the courts, and I've seen no communication on the saggy net in disrepair, which just happens to be the far court on the street in front of the stands. Your signage inside the furthest court explaining how the lights work is covered by very old windscreen. There are weeds, minor pieces of trash, and a ton of ball felt build up along rhe fences and I hope the bathrooms remain stocked. I haven't checked.


The Tennis Coalition of Palm Springs is growing. We look forward to being of service to you in the near future. The official address is:

Maverick Tennis has chosen the Senior Center as a 3rd party recipient of funds from the February event.



Once again I am representing the Ruth Hardy tennis players and I would repeat our thanks for the surfacing of the courts and providing beautiful sun shades for the bleaches.

However, as discussed with Cynthia we have concerns as follows;

1. Water from the sprinklers is streaming onto the new court surface which will eventually erode the surface wasting the vital money that has been spent on resurfacing.


We asked for the grass areas to be replaced with gravel or desert landscaping and the sprinklers turned off. Is this equest a possibility please.
