#### MEASURE J COMMUNITY INITIATED PROJECTS - REVIEW SCORING OF PROJECTS 2.B.

The Commission reviewed the ranking of the projects and discussion ensued between the Commission and staff, below is a summary of the discussion:

- The Commission would consider proposals based on how Commissioners voted (rankings).
- Staff eliminated applications relating to grant requests and proposals outside of the City's jurisdiction. Staff will be notifying applicants that did not meet the approval criteria.
- The Commission reached consensus to eliminate submittals that the majority of the Commission voted to 'not consider'. Therefore, those applications will not move forward for consideration.
- Proposals that include public art components, would be forwarded to the Public Arts Commission for consideration or review.
- The Palms Springs Library Trustees would be invited to the Measure J Oversight Commission meeting of February 17, 2022, to present the library's general plans in addition to their proposal for community initiated projects, submitted in December 2021.
- It was determined that the Commission would further review project proposals and continue the discussion at the next, regularly scheduled, Measure J Oversight Commission meeting of February 17, 2022.
