Good Morning Matthew,

David Morris called us (David Aiken and DuRand Jones) to ask for some input on the Rainmaker fountain. We wrote this up, hopefully it can help with getting the maintenance and repairs made on the fountain. David was on the PS Arts Commission for 10 years, 8 of which he was the Chairman. During his time as chair he worked with David Morris on getting this project started and completed. If there are questions or information that you might need in the future David and I would be glad to help.

The Rainmaker fountain in Francis Stevens Park needs maintenance and possibly repair of that we are sure you are keenly aware. The Rainmaker fountain should be fully functioning as we open the city back up.

Daily during the worst part of the pandemic, we would ride our bikes near the fountain fully masked. The wands spilling water into the basin, very few cars driving by, and some people admiring the work while they were out on their walks was a sight to see during that trying time.

The PS City Council at the time commissioned the PS Arts Commission to build a gateway piece for North Palm Canyon, north of Alejo. At the time of the commission, many of the storefronts were empty and in decline. Since its inception and dedication, the area around it has grown and prospered.

The fountain area has become a point for social gatherings and marches. The fountain is a place where people gather to watch the play of the water. It still is a gateway piece to the north end of Palm Canyon.

The Palm Springs Arts Commission was asked to request entrants nationwide for a gateway project for Francis Stevens park by the PS City Council. I was Commissioner of the Arts Commission at that time. We had many entrants and finally selected Rainmaker by David Morris. We had a review committee that included Stu Williams, Richard Millanovich, and others. This was an ambitious project, outlaying some \$300,000 for a poured-in-place concrete structure with articulating wands, a real deal for the quality of the product produced. Mr. Morris used the best high-end factories, machine shops, and water feature contractors in America to build the wands, with a simple unique concept of the wands moving seamlessly without ball bearings. Mr. Morris was on hand during the pouring of the concrete for the basin and the Arroyo aspect of the fountain. The Arts Commission worked with the planning commission, the city engineers, and the city council to make sure this fountain met the desires of a gateway entrance fountain. Mr. Morris worked diligently to make sure the fountain met the city criteria. Mr. Morris's design in simplicity and complexities can be maintained and was maintained by a very experienced contractor, Rich Parzinsky, who recently passed away.

All projects of this magnitude require annual maintenance and some repairs, and the longer the fountain is not operating, maintenance becomes more costly to bring it back online.

Seeing the fountain wands moving while driving by, walking near, or standing below can be inspiring. It accomplishes the goal of the commission to be the gateway to North Palm Springs.

We would hope that the City and the City Council would move forward with making sure Rainmaker is brought back to its inspiring functioning.

Over the years many friends and acquaintances have purposefully made trips to Palm Springs to see the Rainmaker. But I have recently received notes (both from out of town visitors and residents) that it is not running and appears to need attention.

Many years ago it was discovered that funds allocated for general maintenance of the Rainmaker were siphoned off for other projects, and as a result there was major damage to the equipment. Extensive and costly repairs were made and then assurances were given that maintenance would proceed on a regular basis.

I don't know what has happened, but I understand (from talking with the person now in charge of operations) that although it cannot run at the moment, the problems are not at all as severe this time; some but not all components need attention, and surfaces need refinishing. And this should not be a costly undertaking.

I imagine you have a great deal on your plate these days, but please reassure me that the Rainmaker will get the attention that it needs.
