Brent Sprague, representative from Conserve LandCare discussed changes in Ruth Hardy Park landscaping conversions around the tennis courts and answered questions.

Discussion held on timeline and request to remove grass near mural at front of the James O. Jessie Center.

### VIII. ADHOC & COMMISSIONER UPDATES:

Park Landscape Conversion AdHoc – Chair Alcorn reported that the recent work was discussed in the updated presentation for Desert Highland.

Dog Park AdHoc – Commissioner Miraglia stated that group met last week with a focus on improvements to the Demuth Dog Park. A windscreen was installed on the fence, with plans for leveling and grading the park, addition of a large shade structure in middle of park, and future improvements include a screen to shield softballs from coming into park. Additional discussion ensued on new fencing around park because of CV link and netting to protect everyone from softballs and baseballs.

Master Plan AdHoc – Commissioner Meyer reported that group discussed a timeline for changes the group is reviewing 2014 plans and Master Plans from other Cities to help identify needs and wants for our City.

Park Enhancement AdHoc – No update.

Pickleball AdHoc – Commissioner Finland reported that the group discussed proposals for net barriers, proposals for court signs and decals for whiteboard system, and plans to attend a Parks & Recreation open house as an opportunity to share information about Pickleball. Mentioned the possibility of another survey for players, stated group discussed a volunteer program for Court Ambassadors, and parking issues. Commissioner Finland answered questions from other Commissioners regarding indoor courts, signage already at the Animal Shelter, and decals.

# Commissioner Updates:

Commissioner Spellman inquired about AdHoc meetings and increasing communications.

Commissioner Crawford suggested more features be added at Swim Center to make the pool more family friendly.

Commissioner Meyer commented on Swim Center reservations and staffing of lifeguards. Director Wise explained that the hope is that the lifeguard trainee program offered and recruitment strategy will help the City recruit more people.

Chair Alcorn thanked everyone for attending the meeting. Reminded everyone the next meeting would be scheduled for Monday, February 27, 2023.
