WHEREAS, the problem of low cost housing for a considerable number of people now residing on Section 14 within the City of Palm Springs has been brought before the City Council by private persons and the National Association for the Advancement of Colored People; and

WHEREAS, the City Council desires to investigate said problem with the idea of seeking a solution as to whether said housing should be public or private and the appropriate procedure involved;

NOW THEREFORE BE IT RESOLVED, that the Mayor of the City of Palm Springs be and he is hereby authorized and directed to appoint a committee of five (5) local businessmen to look into the problem of housing for a considerable number of people from Section 14; and

BE IT FURTHER RESOLVED that the said committee shall report back to the Council on the problem after first endeavoring to find a solution for

commending such a project on the basis of private capital, and, if that is not found feasible, then to report to the Gouncil as to the feasibility of establishing such a project under the auspices of the Federal Housing Authority.
