SUBJECT: A REQUEST BY TREE DISPENSARY FOR APPROVAL OF A SIGN

PERMIT FOR TWO WALL SIGNS ON AN EXISTING BUILDING AND A DIRECTIONAL SIGN LOCATED AT 63758 ORR WAY, ZONE M-2. (CASE

SNP-2023-0049) (AR).

PROJECT DESCRIPTION:

Review the design of two proposed wall signs for an existing cannabis business and a small direction sign, located at 63758 Orr Way. The proposed signs will vary in size; sign 1 will be 22.2-square feet and sign 2 will be 6.25-square feet. The directional sign will be located within a planter in the parking lot area. Business signage for a cannabis dispensary is subject to Section 93.23.15(F)(3)(a) for architectural review.

RECOMMENDATION:

That the Architectural Review Committee approve the application as submitted.

ZONING CODE REQUIREMENTS:

Pursuant to Palm Springs Zoning Code Section 92.17.1.01(A)(5) cannabis dispensaries and cannabis lounges are permitted in the M-2 Zone subject to the development standards stated in Palm Springs Zoning Code Section 93.23.15. Section 93.23.15(F)(3)(a) of the PSZC states that any signage for a cannabis facility must be reviewed by the Architectural Review Committee and shall conduct final review for design, size, placement, and materials.

SIGN DESIGN:

As mentioned above, the proposed signs will vary in size. Sign 1 will read "TREE DISPENSARY" and will be internally illuminated. Sign 2 will indicate the entrance, and Sign 3 will indicate Vendor and Customer parking area. Signs 2 and 3 will not be illuminated.










