

- The City uses PlanetBids as its electronic bidding site.
- All formal procurements are posted to this site.
- All communications go through this site during the procurement process.
- Bidders/Proposers upload bids and proposals to this site, so everything is paperless.
- Registering with PlanetBids keeps you informed when procurements are posted
- There is no cost to register with Planet Bids
- Note: quote requests are not placed on PlanetBids



INSURANCE

- Professional Liability (Design Services)

LOCAL BUSINESS ORDINANCE

Pursuant to the City of Palm Springs Local Preference Ordinance 1756, in awarding contracts for services, including consultant services, preference to a Local Business shall be given whenever practicable and to the extent consistent with the law and interests of the public.
