The Commission is seeking highly engaged students that demonstrate the following criteria. By submitting this nomination form you certify that you have read and meet the requirements. All nominations are subject to review by the Commission.

- Demonstrate an understanding of the mission of the Human Rights Commission.
- Demonstrate effective verbal and written communication skills.
- Be a student in good standing (GPA 3.0 or higher).
- A student may be high school, community college, college, trade/vocational school, or university students
- Have experience in extra-curricular activities.
- Have effective interpersonal skills (e.g., influence, diplomacy).

- Comfort working with City staff and officials.
- Have an understanding of the challenges and opportunities that face youth, as itrelates
 to the mission of the Commission, and be able to articulate and advocate the youth
 perspective.
- Must reside, work or go to school within the City of Palm Springs PSMC 2.06.010.

What's Involved in being a Student Representative on the Human Rights Commission?

- Attend monthly Commission meetings (second Monday of every month) and other events as necessary.
- Advise the Commission on issues, concerns or opportunities important to youth.
- Workwith Commissioners to set goals for the year and work collaboratively to accomplish those goals.
- Student term is approximately September-August.

The term of appointment for each student selected to serve a term or terms as a Student Municipal Representative are established and stated at the time of their appointment. Student representatives will serve from September through May. Appointments do not carry over from year to year. Students may reapply each year for the same or different commission.

Student commission members are required to attend all commission meetings and conduct him/herself in a professional manner. Missing more than two meetings or unprofessional conduct that is disruptive to the proceedings may be cause for dismissal from the program. Student representatives are encouraged to participate in the meetings, but are not a voting member of the commission.

The City of Palm Springs does not discriminate on the actual or perceived race, religion, color, sex, age, marital status, ancestry, national origin (i.e., place of origin, immigration status, cultural or linguistic characteristics, or ethnicity), sexual orientation, gender identity, gender expression, physical or mental disability, or medical condition.

Human Rights Commission, Student Representative Program

The City of Palm Springs is offering a government representative program for students interested in applying for a non-voting position on the city's Human Rights Commission. The student representative program is designed to encourage volunteerism, civic responsibility and provide valuable real-life experiences for high school students who live in Palm Springs.

Participants will attend their first meeting in September. Students successfully completing the student representative program will be recognized by City Council Members in May of the following year and receive special recognition for their civic contributions to the community.

REQUIREMENTS: To be considered for a student position, students must complete and submit a Student Representative Self-Nomination Form and participate in an interview process. If accepted, attend monthly meetings during the school calendar year. Students are invited to apply at any time during the school year. Must reside, work or go to school within the City of Palm Springs PSMC 2.06.010.

HOW TO APPLY: Complete and submit the Student Representative Self-Nomination Form as well as a letter of interest describing why you would like to serve on the Human Rights Commission at the City of Palm Springs. Students have the option to submit endorsements from teachers, administrators or peers (maximum of three endorsements).
