The path that brought us to the Commission

- Cannabis Event Workgroup commenced February 1, 2024
 - 3 meetings between February 1, 2024, through March 13, 2024
 - Topic of discussion: Where in the City would be a sufficient place to hold Cannabis events?
 - Feedback from workgroup was the City's Parks; including the Downtown Park

Cannabis Adult Use Related Activities

- Cannabis Adult Use Related Activities is regulated by Palm Springs Municipal Code (PSMC) 5.55
 - PSMC 5.55.100 is specific to Temporary Cannabis Event Permits
- California regulates Cannabis activity under the Medicinal and Adult Use Cannabis Regulation and Safety Act (MAUCRSA)
 - Requires annual State Cannabis Event License and a Temporary Cannabis Event License for each event

Temporary Cannabis Event Permit

PSMC regulates and requires that

- The Temporary Cannabis Event complies with the locational requirements of the City's Zoning Ordinance.
- The Temporary Cannabis Event includes adequate measures that minimize, to the extent feasible, nuisances to the immediate neighborhood and community including minimizing the detection of odor from onsite, minimizing the effects of loitering, providing adequate security measures, and not exceeding the Land Use Permit's limits on hours of operation.
- The Temporary Cannabis Event, as approved and conditioned, will not result in significant unavoidable impacts on the environment.
- The Temporary Cannabis Event will provide adequate measures that address the federal enforcement priorities for Cannabis activities including restricting drugged driving, restricting access to minors, and ensuring that Cannabis goods are supplied from permitted and licensed sources.

Our Goal

- To receive feedback from the Parks and Recreation Commission on pros, cons or other feedback relating to the use of the City's Parks as a place to permit Cannabis Temporary Events
- Report these finding as part as our staff report to the Planning Commission in May 2024
- It is required from the State that local municipalities, if desired to permit Temporary Cannabis Events, to have codified language on specific locations.
- The goal is to have Planning Commission review and recommend findings
- The findings will be presented to City Council in June 2024
- The Department of Special Programs welcomes Commissioners to attend to provide feedback
