2A. A REQUEST BY GIUSEPPE COMPERATORE, ON BEHALF OF DOGS R DOPE, LLC, FOR A CONDITIONAL USE PERMIT TO INCORPORATE OVERNIGHT KENNELS WITHIN AN EXISTING DOG TRAINING AND CARE FACILITY AT 888 EAST RESEARCH DRIVE, ZONE M-1-P (CASE NO. CUP-2024-0004) (AR).

- 1. A minimum of 280 square feet of usable outdoor dog space will be provided.
  - a. Pervious material used for a minimum of 50% of the surface.
  - b. 50% of the area to be covered by shade.
- 2. Two outdoor visits for each dog kenneled overnight (24 hours).
- 3. A maximum number of 40 dogs at the facility at any given time.
- 4. Maintenance of landscaping in the front yard.
- 5. Adequate plans provided to the Planning Director to remediate sanitation complaints in 90 days.
- 6. Ensure that the facility and outdoor areas are always maintained in a clean and sanitary condition, and the submission of sanitation plan to the Planning Director.
- 7. Maintenance of a refrigerator on site for pet food requiring refrigeration.
