- Currently working to develop draft language for the plaque.

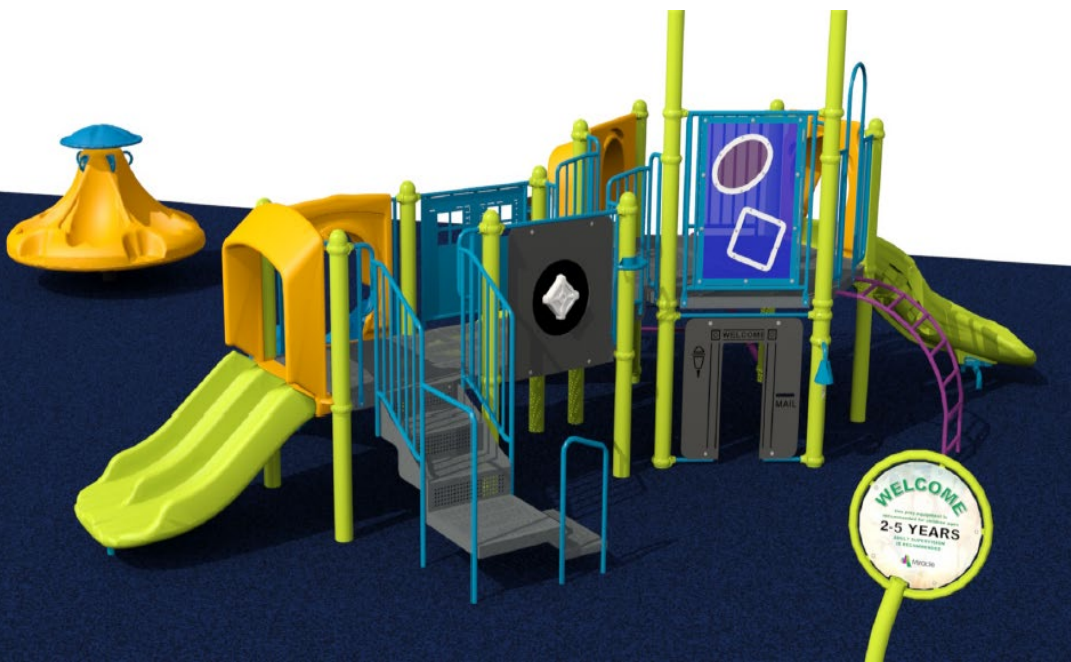
